- Elections Election for the European Rowing Confederation Constitution, Article 13. In the case of 2021, the Transitional Arrangements agreed in November 2018 cover the situation in 2021:
  - a. European Rowing Board MF Representatives According to the 2018 Transitional Arrangements, the terms of office for the MF positions on the ERB include Ryszard Stadniuk and Annamarie Phelps (2021), Nebojsa Jevremovic (2022), Eva Szanto (2023). An election will be held for two members of the ERB, one for a four-year term ending on 31 December 2025 (currently held by Annamarie Phelps) and one for a three-year term ending on 31 December 2024 (currently held by retiring Ryszard Stadniuk) thus completing the transitional arrangements for these elections.
  - b. ERC Chair Ryszard Stadniuk (POL) was elected Chair in 2019 for a transitional term until the 2021 General Assembly. As Mr. Stadniuk reaches the age limit in 2021, an election for the position of Chair of the ERC and ERB for a four-year period ending 31 December 2025 will be held and the eligible candidates are the four European Rowing Board MF Representatives (including the newly elected two in point a. above).
  - c. World Rowing Representatives The positions of the World Rowing Council's representatives on the European Rowing Board are currently held by Patrick Rombaut,

BEL, Algirdas Raslanas, LTU and Dusan Machacek, CZE. According to the European Rowing Confederation Constitution, Article 13.2.1, the terms of office expire in 2021. Therefore, voting will be held based on proposals presented by the World Rowing Council.
